Subject: Whether or not to initiate public consultation on the proposal to enlarge Amwell View School, Stanstead Abbotts, through the opening of a new satellite provision in Buntingford, from January 2028.

1. Decision

Whether or not to initiate public consultation on the proposal to enlarge Amwell View School ("The School") by 100 places through the opening of a new satellite provision in Buntingford, from January 2028

The School is a community special school for children aged 2-19 with Severe Learning Difficulties (SLD).

2. Reasons for the decision

In December 2020, the Cabinet of Hertfordshire County Council ("the county council") approved the Special School Place Planning Strategy 2020-2023, which sets out that demand for special school places has grown sharply in recent years and is forecast to continue to grow at a rate that will exceed the current supply of places. As the majority of

Hertfordshire's special schools are now at capacity, the strategy sets out longer-term priorities which will deliver the additional school places required. However, in the short term, it identifies that additional capacity will be needed to meet the immediate demand for special school places.

Currently there are 153 children in Hertfordshire awaiting an SLD school place, 16 of whom have been waiting over three terms. The county council's Ofsted Action Plan sets out that the county council should have no pupils waiting over three terms by January 2025.

The Integrated Plan 2024/25 to 2027/28 included £40.5m to support SEND capital investment, including £25.5m against a specific priority; to deliver 100 new SLD places to the east of the county. There is a current gap in provision and this location will not only ease pressure to the east of the county, but also in Stevenage and North Herts.

Feasibility on a scheme to deliver these places on an HCC owned site in Buntingford is now sufficiently progressed to move to public consultation. It is proposed that the new places will be delivered through an expansion of Amwell View, an outstanding SLD school in Stanstead Abbots, by 100 places utilising the site in Buntingford. This will require a full statutory process.
