Peterborough and later Cambridgeshire councils were both fortunate enough to be awarded funding to implement the Family Safeguarding models. Lou played a central leadership role in the successful implementation of the model across these two very different local authorities. This included ensuring that Corporate Leadership Teams, Members and key partner agencies were fully signed up to the model, and then remained committed to its continued development.

The impact of Family Safeguarding in both Peterborough and Cambridgeshire was extremely positive, with significant reductions in the number of children subject to child protection plans and coming into care. This created a powerful narrative in respect of sustainability, since the model is not only demonstrably better for children and their families, but the investment in additional staffing including the adult-facing practitioners, is more than offset by the reduction in placement costs for children in care.

Having now taken early retirement, Lou is working with the Centre for Family Safeguarding Practice and will use his experience of implementing the Family Safeguarding model to support local authorities seeking to do the same.



Edwina Grant OBE Independent Consultant

Edwina Grant OBE is a consultant to The Centre for Family Safeguarding, alongside other work she does with the Chartered Institute of Public Sector accountants (CIPFA), Whole Education, Newton, and several local authorities.

She was Director of Children's Services (DCS) in four councils, the London Borough of Redbridge, Nottingham City Council, Central Bedfordshire Council, and Lancashire County Council.

Redbridge was one of two councils that trailed the concept of the DCS post back in 2003, before the Children Act 2004, so she has a good sense of social care developments and emergent issues that affect DCS's and councils at executive level since then. She worked for four years with

the Local Government Association (LGA) as their senior children's services adviser and sat on the Ofsted reference group for many years. For four years she was a Trustee on a large hospital acute trust, which deepened her understanding of the health and NHS agendas.

A qualified teacher, with a background in Special Educational Needs, she was awarded the OBE for services to children's social care in 2015. She sits on the Association of Directors of Children's Services (ADCS) council of reference as chair of the ADCS associates.
